1. Information We Collect

We collect only limited information, including:

 - **Technical information collected automatically:** IP address, browser type, device information, operating system, referring pages, and access times.
 - **Cookies and analytics data:** to understand website usage and improve user experience.

2. Purpose of Collecting Personal Data

We collect and process your personal data only for the following purposes:

We do not process your data for any other purpose without your consent.

3. Legal Basis for Processing

We process your personal data only when:

 - Processing is required to comply with Omani law.

4. Cookies and Tracking

5. Data Sharing and Disclosure

We do not sell or rent your personal data. We may share your information only in the following situations:

 - If required by law or legal authorities in Oman.
 - In the event of a business restructuring, merger, or transfer (with protections applied).
